## New project of "Family Reunification" labeled as new mockery made to the Cuban family

The bill introduced in Miami by congress representatives Mario Díaz-Balart and María Elvira Salazar was labeled as a new mockery made to the Cuban family as it aims to move the visa processing to the US Naval Base in Guantánamo.

*"In my 40 years of experience as an immigration lawyer in this community, I had never seen such a mockery made at the expenses of the painful separation of the Cuban families,"* stated the immigration lawyer Wilfredo Allen, according to El Nuevo Herald.

*"Both, María Elvira and Mario, know that it is unrealistic to trying to pass this bill. They know no one will take it seriously. Why do they do it? Because it is useful and quite profitable to play with the despair of Cuban families. Plain and simple,"* Allen said.

The lawyer's statements were taken from an interview made to the expert by **Cubita Now** website where he, indeed, highlighted he felt *"embarrassed and angry due to two particular reasons essentially: firstly, I voted for Salazar, and secondly, because Mario knows perfectly the magnitude of the nonsense they are introducing."*

For the Miami-based lawyer, this nonsense starts from the moment they announced they would aim for family reunification to become law.

*"So it has been impossible for the Congress to agree on passing commonsense laws that allow an orderly immigration to this country. None of these Cuban American congress representatives and senators (except for Bob Menéndez) opened their mouths in the last four years to resume the 20,000 visas annually for Cuban people, and they say now they aim for a legislation for Cubans. First, Martians will land in Miami before the bill can be even taken into consideration in the Congress."*

This Allen's definition confirms, to some degree, the approach of Yunior Smith, journalist at the Cuban National TV News, who stated in the report on the subject that this absurd proposal was only to pass the hot potato to the

Cuban government on this very sensitive issue.
