
EDITORIAL: NATO-RUSSIA Conflict and the New World Information Disorder

In addition to confirming, once again, that the truth is the first casualty of any war, especially if it is inspired by the so-called "leaders" of the world, the conflict in Ukraine has made it clear the side of the so-called private companies known as social media.

How, then, is its rapid subordination to the "orders" of the so-called Western world, which militates in the increasingly expansive NATO, explained?

The economic war unleashed by the United States and its European minions against Russia may be disastrous, but its consequences for the planet remain to be seen, as is the case with the predicted new world political configuration. However, the war in Ukraine has already shown, from the media perspective, to which new information disorder these self-defined "*democratic*" channels of "*communication*" respond to.
